#### **Resolution 7-2022**

# A RESOLUTION AUTHORIZING THIRD PARTY PLAN REVIEW AND INSPECTION FOR RESIDENTIAL AND COMMERCIAL BUILDINGS FOR THE TOWN OF MOUNT MORRIS, NEW YORK

Supervisor DiSalvo presented the following resolution pertaining to the NYSERDA Commitment

WHEREAS, New York State has adopted the 2018 International Building Code family of codes with amendments, named 2020 Codes of NYS, as the guiding principle pertaining to residential and commercial construction and development within the state; and,

**WHEREAS**, The Town of Mount Morris realizes that to promote public safety and preserve the quality and value of property within the community, coordinated development review processes are essential to ensuring that the adopted, nationally recognized building codes and best practices are incorporated into buildings and structures; and,

**WHEREAS**, third party plan review and inspection services will only be for ECCCNYS or NYStretch compliance review. Review by other departments in the Town of Mount Morris will still be required; and,

**WHEREAS**, the Mount Morris Town Board deems it in the best interest of the citizens of the Town of Mount Morris to authorize the Building Official to allow third party plan review for residential and commercial buildings in the Town; and,

**WHEREAS**, time of performance and terms of service are negotiated solely between the permit applicant and third-party plan review and inspection services provider; and,

**WHEREAS**, it shall be the permit applicant's responsibility to ensure the third-party plan review and inspection services provider receives all the necessary construction documents and list of municipal requirements. Approved stamped documents shall be submitted to the Zoning and Code Department prior to the issuance of a building permit.

NOW, THEREFORE, BE IT RESOLVED BY THAT THE TOWN BOARD OF THE TOWN OF MOUNT MORRIS, NEW YORK:

**SECTION 1.** The findings and recitations set out in the preamble to this Resolution are found to be true and correct and are hereby adopted by the Town of Mount Morris Town Board and made a part of hereof for all purposes.

**SECTION 2.** The Town of Mount Morris shall hereby authorize the Building Official to allow third party plan review and inspection for compliance with the Energy Conservation Construction Code of New York State

**SECTION 3.** This Resolution shall be and become effective from and after its adoption.

However, as the Board does have a plan for a new Clerk to be appointed as of November 1, 2022, Town Clerk Davis cannot remain on to train part time.

# AMBULANCE REPORT

Supervisor DiSalvo reported that the Ambulance took 109 calls this month to include 35 ALS, 37 BLS, and 6 calls to the prison. He reported that the Mount Morris Ambulance crew has been helping out the Nunda crew. Supervisor DiSalvo reports that the rigs are running good at this time.

# **HIGHWAY SUPERINTENDENT REPORT**

Highway Superintendent Cipriano reports that the Town trucks are ready for winter. He shared that the highway crew has been taking care of the cemeteries and Town parks, although one season crew member has returned for a short time to assist in the caretaking.

# **CODE ENFORCEMENT REPORT**

CEO Grasby informed the Board that EDF Renewables is asking if the east end of Creveling Road could be closed off during construction phases. There is concern that supply vehicles may get stuck trying to climb the steep hill there. Superintendent Cipriano stated that he will look into the route closing process and barriers to close the road there.

CEO Grasby shared that he inquired further in regard to what would be included as a viable energy savings project under our recently awarded NYSERDA Grant. He stated that the first \$50,000 could be used towards replacement of windows at the Town Hall. Supervisor DiSalvo and Superintendent Cipriano stated that they would reach out to potential contractors for quotes (to include asbestos abatement as it is present in the window frames).

CEO Grasby reports that there are new projects in front of the Planning Board at this time.

CEO Grasby added that EDF Renewables did compliance filings for tree clearing for the Morris Ridge Solar Project. Removal is on track to begin next year in late spring or early summer.

CEO Grasby reports that the grant money for ambulance equipment will be sent. He shared that Kevin Davis from EDF Renewables will be working on accessing and releasing \$80,000. He will be sending funds to cover a drone for Livingston County. CEO Grasby talked about why the Town is getting various equipment, in particular transport equipment for the ambulance to utilize. He explained that in order to get into the solar farms, due to tight spaces, the ambulance needs an ATV and trailer.
