Town of Mount Morris Regular Meeting January 21, 2021

At 6:30 p.m. Deputy Supervisor David DiSalvo opened the Town Board meeting at 103 Main Street, Mt. Morris, NY.

The Board reviewed minutes of the last regular meeting. A motion by Councilmember Huff, seconded by Councilmember Woodworth, to approve the minutes of the meeting on December 17, 2020 as presented.

Accountant Terri McKerrow reviewed the Supervisor's Report. She stated that with the exception of Fund SR, every fund performed above expectations. She provided the Board with recommended budget transfers. A motion by Councilmember Huff, seconded by Councilmember Guzzardi, to make the following budget transfers:

Councilmember DiSalvo stated that EDF Renewables is part of a \$43,000 Agrivoltaic study. This is to study the coexistence of solar farms and agricultural uses such as sheep raising or bee keeping. A motion by Councilmember Woodworth, seconded by Councilmember Guzzardi, to approve signing of a contract between the Town of Mount Morris and Mount Morris Energy Center LLC regarding this study.

Motion passed Vote: Aye No

Councilmember DiSalvo reported that the ambulance service had 109 calls in December and covered 96 of them, with 34 being Advanced Life Support and 29 were Basic Life Support. Two were for the prison. The rigs do not need winter tires, so that saves funds. The ambulance service purchased a doppler to scan a patient waiting for a heart transplant since there is such a patient in our community. Only one other ambulance service in the county has this equipment.

Councilmembers Woodworth and Guzzardi had nothing to report.

Code Officer Grasby reported that the water study by MRB is moving forward. They are applying for grants for the expansion of the Town's water system. Councilmember DiSalvo stated that expansion would require the formation of another water district.

Superintendent Cipriano reported that the Highway Department has been busy recently with the plowing of snow. Prior to that they installed a few crossover pipes.

Councilmember DiSalvo informed Highway Superintendent Cipriano that the Town will need to have a contract with the fire district for the maintenance of fire hydrants, and asked for his input. The Village is charging \$100/year per hydrant. The Town needs to decide on a rate for hydrants. A motion by Councilmember DiSalvo, seconded by Councilmember Huff, to contract with the Fire District for \$25 annually per hydrant.

Councilmember Woodworth wants to know what the Town's responsibility is regarding these hydrants.

Assessor Knapp reported that in December, the Governor waived the need for renewal of property tax exemptions due to COVID. Property owners can renew if they wish to, otherwise, it's assumed that their income is the same as the previous year. If the Assessor has reason to believe that there has been a significant change in circumstances, he can request that they complete a renewal application. He provided the Board with a sample resolution from New York State. A motion by Councilmember Huff, seconded by Councilmember Guzzardi, to ADOPT the following resolution:

WHEREAS, pursuant to executive order 202.83 signed by Governor Andrew M. Cuomo on December 18, 2020 WHEREAS, hereby, the provisions listed in Subdivisions 7, 7-a and 8 of section 459-c of the Real Property Tax Law, and subdivisions 5, 5-a, 5-b, 5-c and 6 of section 467 of the Real Property Tax Law requiring an annual application, are hereby waived for the 2021 assessment roll year to the extent necessary to permit the assessor to grant exemptions pursuant to such section on the 2021 assessment roll to all property owners who received that exemption on the 2020 assessment roll, thereby dispensing with the need for renewal applications from such persons, and further dispensing with the requirement for assessors to mail renewal applications to such persons.

WHEREAS, provided however, that renewal applications will still be required when the assessor has reason to believe that an owner who qualified for the exemption on the 2020 assessment roll may have since changed his or her primary residence, added another owner to the deed, transferred the property to a new owner, or died. Now, therefore be it,

RESOLVED, that the Town Board is authorized to pass such resolution, and that the assessor is instructed to take any such necessary actions in the above described directives.

Vote: DiSalvo Aye Huff Aye Guzzardi Aye Woodworth Aye Resident Bill Benson asked about the status of the greenhouse project. Councilmember DiSalvo replied that it's currently on life support. The location on Route 408 was ruled out due to inability to make an agreement on the cost of the land. The second location created an uproar in the neighborhood and the company dropped their actions. The location has to be (in part) within the Village limits because that's the only Opportunity Zone in Livingston County.

Councilmember DiSalvo asked Superintendent Cipriano about the Town's commitment for road salt. He replied that we have ordered 900 tons and are committed to receiving 70% of that. He hasn't needed to order any yet since the winter has been so mild.

EDF Renewables will be holding a meeting to explain the transition from New York State's Article 10 to the new Section 92 process. Code Officer Grasby stated that Intervenor Funds need to be done by February. The allowance is \$1,000 per megawatt and the Town's share was increased from 50% to 75%.

The Clerk stated that the Town received an Invoice for \$3,300 from the Village for the 2021 Youth Recreation Program. The Town paid the Village \$3,200 in 2020 for this program, but due to COVID, no program was held. There is a contract between the two municipalities for this program, and the Board wants to know if they can withhold payment due to the lack of a program last year. The legal team will look into this. A motion by Councilmember DiSalvo, seconded by Councilmember Woodworth, to table the decision about payment for the 2021 Recreation Program.

The Board reviewed the Clerk's monthly report. A motion by Councilmember Huff, seconded by Councilmember Woodworth, to approve the Clerk's December report as presented.

There was a discussion regarding the fact that we still have no answer from the Town attorneys regarding the possibility of using the cemetery's "perpetual fund" that was to generate interest for maintaining the cemetery without using any of the principal. The investment firms no longer handle such accounts, so the Town wants to know if it's legal to now use the principal amount. The lawyers asked if anyone had information regarding the initial investment. No one knows the origin of this since it had belonged to the Cemetery Association. The cemetery is more than 100 years old, so this information may no longer be available. The Clerk suggested that perhaps Junior Stanley would know something about it since he managed it for many decades.

Irene Bodnaruk was attending the meeting via Zoom, and expressed some concerns about the current Comprehensive Plan review. She commented that it made no mention of the water study, lacks detail, and doesn't seem to contain as much information as the old Comprehensive Plan. Councilmember DiSalvo stated that the old Comprehensive Plan was done jointly with the Village, and the new one is strictly the Town, so it would be smaller. He'll look into her concerns.

The Board took action in the past on the closure of a portion of Kapprell Road. Afterwards, it was determined that the description was inaccurate. Attorney Russell revised the description. A motion by Councilmember Woodworth, seconded by Councilmember Guzzardi to close a portion of Kapprell Road based on the new description.

The Clerk informed the Board that when Thoma Development held the Public Hearing for the Comprehensive Plan Review, not enough members of the Steering Committee attended to have a quorum. In fact, some members originally appointed to the Steering Committee haven't attended a single meeting and have been removed. The Clerk, on the other hand, has attended all of the meetings. If the Board would appoint the Clerk to this committee, she could help to close this gap since the number needed to make a quorum in this case will not increase. A motion by Councilmember Huff, seconded by Councilmember Woodworth to appoint Town Clerk Christie Murphy to the Comprehensive Plan Steering Committee.
